CITY COUNCIL MEETINGS

The City Council's next regular meeting is on **Monday, May 6, 2019** beginning at 7:00 p.m. in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. CITY CLERK AND COMMUNITY RELATIONS UPDATES

- **Evergreen Award Nominations Now Open:** Nominations for our tenth Evergreen Awards program are open through May 31, 2019. Nomination forms are available online at www.cityofmlt.com/481. The Evergreen Awards Program builds the community's pride, enhances the community's image, and promotes sustainability. This week, the Community Relations Director visited all six neighborhoods and began taking photos of properties that were nominated and spoke to several property owners. This work will continue through the spring and early summer.
- **Website Redesign:** Monday, May 6, the City Council will get a preview of the city's new website. The launch is currently planned for mid-May, however there are still some technical issues the city is addressing and trying to work through with CivicPlus that could delay the project a week or two.
- **Lodging Tax Advisory Committee (LTAC) Meeting:** On May 2, the LTAC had a follow up meeting to review the city's current application and criteria for funding in follow up from their 2018 meetings. The Committee provided feedback to the City Clerk to draft some revised materials for them to review before they meet again. Once the materials are drafted, they will be reviewed by the City Council for approval.
- **National Night Out:** Planning has begun for the city's annual National Night Out Against Crime event that takes place on Tuesday, August 6. The city has reached out to potential sponsors and to date, Premera Blue Cross and AFCO and Sons have made donations to this year's event with some potential sponsorships on the horizon. Thank you to Premera, AFCO & Sons and our other local businesses for supporting this event that unites our community!

COMMUNITY & ECONOMIC DEVELOPMENT UPDATES

- **City Hall & Police Station Addition:** On Thursday, April 25, the City hosted a public meeting to view renderings and listen to presentations by four local artists selected to present their designs for public art for the new Civic Campus redevelopment project. Attendees included members from the Mountlake Terrace Arts Advisory Commission, City Council, Call for Artists selection panel and public. Doors opened to the public at 5:30 p.m. and presentations began at 6:00 p.m. in the Mountlake Terrace Library. The Arts Advisory Commission and Call for Artists selection panel will meet in mid-May to discuss the proposals. This will be followed by the Arts Advisory Commission forwarding a recommendation to the City Council.

- **Sound Transit:** Interim temporary parking lot site plan for the former Roger's Market and parking lot is still under review. Sound Transit has resubmitted application materials to achieve a determination of complete application on the site plan proposal. A Conditional Use Permit application review for Sound Transit continues.
- **216th Townhomes:** The Planning Commission held a public hearing on Monday, April 8 for a 12-unit/lot townhome development comprised of two 3-story buildings, with six single-family residential units in each. The 0.6 acre lot was previously developed with one single-family home that has since been demolished.
- **Creekside Meadows:** A 56-unit PUD located at 7011 226th Pl SW, has resubmitted civil construction plans for review, to be consistent with the preliminary plat and PUD approval received in December 2018.
- **Town Center Plan Update:** The Planning Commission will meet on Monday, May 13, 2019 (meeting #8) to discuss and consider the Economic Vitality and Town Center Task Force's recommended draft Town Center Sub-area Plan. The meeting will take place in the Mountlake Terrace Interim City Hall (6100 - 219th Street SW).

A public meeting will be held prior to the May 13, 2019 Planning Commission Meeting to introduce and discuss the EIS scoping and potential planned action for the draft Town Center Subarea Plan Update. The meeting will also take place in the Mountlake Terrace City Hall Council Chambers.

PUBLIC WORKS (ENGINEERING & OPERATIONS) UPDATES

- **Main Street Construction Update:** Daytime closures on 236th St SW and 58th Ave W will continue for the next couple of weeks to allow the contractor to install some large vaults. Both streets will not be closed at the same time and appropriate detours will be in place. Full street closures are allowed between the hours of 9:00 a.m. to approximately 4:00 p.m. The contractor's schedule shows one closure on 58th for next week with multiple closures occurring on the following week. The 56th Avenue W roadway will remain open to both north and southbound traffic during these closures.

Motorists and pedestrians are reminded to be alert in the construction zone and follow guidance signs and flaggers.

The closure allows the contractor's underground utility work to continue. Installation of the conduits and large vaults has been challenging at street intersections where conduits overlap and connect to the vaults from multiple directions.

Traffic will continue to divert from 236th Street SW through the neighborhoods during this period. Community Transit and King County Metro will also continue to operate on detour routes during these daytime hours to minimize delays.

- **Controlling Aquatic Weeds in Lake Ballinger, May 29, 7 p.m. to 8:30 p.m. Mountlake Terrace Senior Community Center 23000 Lakeview Drive:** Lake Ballinger has in recent years become infested with invasive aquatic weeds, including Eurasian watermilfoil, fragrant water lilies and curly leaf pondweed. The thick aquatic plant beds that cover most of the nearshore area have negatively impacted boating, swimming, and fishing in the lake. Invasive weeds have also reduced water quality. In order to address the problem, a citizen steering committee has recommended a control plan including use of burlap bottom barriers and aquatic herbicide applied to 50 percent of the lake during summer 2019.

This **free, public workshop on Controlling Aquatic Weeds in Lake Ballinger** will cover:

- Revisions to the 2018 aquatic weed control plan (including using a different herbicide and increasing the amount of treatment area in the lake)
- How to control aquatic weeds by hand
- Stopping the spread of aquatic weeds

- **Aquatic Staff Training:** Friday, May 3 was an all aquatic staff in-service where the focus was rescues and scenarios. This in-service will be run by the Head Lifeguard/Swim

Instructors who have been mentored by the Aquatic Coordinators throughout the year. Staff will go over basics of rescues and have simulated scenarios.

- **Memorial Day Schedule:** The Memorial Day weekend schedule has been posted online at <http://www.cityofmlt.com/531/Pool-Schedule>. It is also available in the lobby of the Recreation Pavilion. All Recreation swims starting with the Friday 4:30-6:00 p.m. swim will be \$3.00 all weekend. The Recreation Pavilion will be closed in observance of the Memorial Day Holiday on Monday, May 27.
- **Dog Training Classes:** The Dog Obedience classes are continuously filling and running this year. New sessions began on May 6 for Basic Dog Obedience, May 8 for Beyond Basic Obedience and May 9 for Puppygarten. These classes will run through June. Classes are taught by Caren Malgesini who is a Certified Professional Dog Trainer.
- **WRPA Aquatic Network:** On Thursday, May 16 Aquatics will host a Washington Recreation & Park Association (WRPA) Aquatic Network meeting. Aquatic Professionals, Supervisors and Coordinators from around the Northwest attend this meeting to share information, provide facility updates and discuss problem solving. Recreation Coordinator/Aquatics, Mark Feeny is the Network Lead for this group.
- **Espresso Special:** Next week's espresso special will be Coffee Nudge Mocha. Come to the Recreation Pavilion espresso stand and receive \$0.50 a 16oz, iced or hot.
- **New Electronic Reader Board:** City Recreation staff partnered with Edmonds School District to purchase a new electronic reader board. The reader board was installed on April 23 at the corner of 56th and 228th. The new LED display will increase visual interest as well as save electricity.
- **Veterans Park Volunteers:** Park staff have met with Kory Rigler with an interest in holding a volunteer clean up event in Veterans Memorial Park on May 31 through June 2. Projects planned are to include trash pickup, moss removal, graffiti removal, spreading bark, spreading play chips, as well as painting the gazebo, the play equipment, picnic tables and benches.
- **Parks Department Preparing for Summer:** Park staff started the ballfield irrigation systems as we head into the summer months. Staff started a vigorous mowing schedule, pressure washing, and weed control.
- **Earth Day/Arbor Day:** The City of Mountlake Terrace Recreation and Parks Departments held an Earth Day and Arbor Day Volunteer event on Saturday, April 27 at Ballinger Park. More than 50 participants met at the Ballinger Park Clubhouse with gloves and tools in hand. Members from the City Council, Recreation Park Advisory Commission, the Neighborhood Park Improvement Subcommittee as well as the Mountlake Terrace Ballinger Organic Garden (MLTBOG), the Mountlake Terrace Dog Off-leash Group (MLTDOG), the Mountlake Terrace Senior Center and Plant Amnesty were also on site. Work completed included litter clean up, flower bed maintenance, garden bed plantings as well as invasive

plant removal along Hall Creek and within Ballinger Park. All volunteers were treated to lunch by the City Council and received a free one gallon tree in honor of Arbor Day from the City working with the Conservation District.

Weekly Patrol Synopsis

- On April 24 beginning at 10:07 a.m. patrol responded to several vehicle prowls/theft crimes in the 23000 block of Lakeview Drive. Several victims reported their vehicles were broken into overnight and various property was stolen. There is no suspect information, investigation continues.
- On April 24 at 1:18 p.m. patrol responded to an attempted burglary in progress in the 5400 block of 216th Street SW. The victim reported upon arriving home she observed a subject she did not know trying to get into the residence through the garage door. The suspect fled

on foot. Officers responded to the area, established a perimeter and confined him to the neighborhood. He was observed running through various yards over the next several minutes. Eventually he was apprehended and arrested. He was booked at the Snohomish County Jail for multiple counts of trespassing in addition to warrants for his arrest.

The victim reported she discovered multiple unauthorized transactions were made against her bank account. Investigation revealed the account was compromised and the suspect(s) were able to make a duplicate debit card. There is no suspect information, investigation continues.

The subject was taken into protective custody and involuntarily committed for a mental health evaluation.
- On April 25 at 9:12 p.m. patrol stopped a vehicle for moving violations in the 22800 block of 48th Avenue W. Investigation revealed the occupant to have a warrant for her arrest. She was arrested and released to the custody of an Edmonds officer for booking.

The suspect was recently released from jail and arrived home. He initiated a verbal altercation with his brother where he threatened to kill him. Due to the recent instability of his brother and the circumstances surrounding the threat the victim feared for his safety. The suspect was arrested and booked at the Snohomish County Jail for the crime without incident.
- On April 26 at 8:29 a.m. patrol responded to a death investigation in the 21300 block of 52nd Avenue W. The reporting person said upon exiting their residence they found the decedent on the ground. Investigation revealed nothing suspicious and the individual to be suffering from a variety of medical issues. A deputy medical examiner responded and took possession of the deceased. Investigation continues.

The victim reported her vehicle was broken into and a variety of financial instruments stolen. Further investigation revealed the suspect(s) made multiple unauthorized charges on credit cards. CODE ENFORCEMENT PROPERTY OF THE WEEK

On April 16, 2019, Code Enforcement received a parking complaint of multiple non-electric vehicles parked in electric charging station stalls at the Community Transit Center parking (6000 block 236th Street SW). When Code Enforcement arrived, they observed a Honda Accord, Hyundai Sonata and Mini-Cooper, all gas powered non-electric vehicles parked in the "Electric Vehicle Charging Only" stations. Code Enforcement issued parking citations to all three vehicles in violation of the following; 10.10.065-(No person shall park a vehicle in an electric vehicle charging station provided on public or private property if the vehicle is not connected to charging equipment). For the purposes of this section "electric vehicle charging station" means a public or private parking space that is served by charging equipment that has as its primary purpose the transfer of electric energy to a battery or other energy storage devices in an electric vehicle.



OTHER ITEMS OF INTEREST

- Commissioned staff attended the range where they were tested for proficiency with their pistol, rifle and shotgun.
- Commissioned staff were tested for proficiency with the use of the SAGE. The SAGE is a less lethal device that discharges rubber baton type projectiles.
- Sergeant Porter instructed multiple regional Complex Coordinated Terrorist Attack training sessions attended by first responders from multiple agencies.
- Officer Brecht and Sergeant King attended specialized training regarding DUI enforcement.
- Chief Caw approved the background investigation for certified entry police officer candidate Jeremy Voeller. He will be starting May 20 and attending the CJTC equivalency academy shortly thereafter.
- Entry level police officer recruit Noah Rodgers began the Basic Law Enforcement Academy on April 30.
