

CITY MANAGER'S WEEKLY UPDATE

June 28, 2019

CITY COUNCIL MEETINGS

The City Council's next regular meeting is on **Monday, July 1, 2019** beginning at 7:00 p.m. in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. The City Council agenda includes: (1) Approval of Apply-A-Line Contract for 2019 Road Striping Maintenance; (2) Lake Ballinger Aquatic Weeds Control: a. Approval of Interlocal Agreement with City of Edmonds; b. Approval of Professional Services Agreement with TetraTech; and c. Approval of Professional Services Agreement with AquaTechnex; (3) Consideration of Arts Advisory Commission Recommendation of Artist for Civic Campus 1% for the Arts; and (4) Quarterly Discussion and Update of City Council Goals.

The City Council's next work/study session is on **Thursday, July 11, 2019** beginning at 7:00 p.m. in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. The City Council agenda includes: (1) Introduction of Town Center Subarea Plan and 2018 Comprehensive Plan Amendments; (2) Discuss Naming of Van Ry Boulevard; (3) Review of Mountlake Terrace Salary Commission Appointees (Tentative); (4) Review of City Council Subcommittee Recommendation for Planning Commission Member Appointment.

COMMUNITY MEETINGS AND EVENTS

- **City Hall & Police Station Addition:** Call for Artists process: The Arts Advisory Commission met on May 21, June 5, and June 18, 2019 to discuss artists' proposals presented during the April 25, 2019 open house. After consideration of the proposals, the Arts Advisory Commission has voted to recommend working with two artists, i.e., Louise McDowell and CJ Rensch, as part of the Civic Campus Redevelopment project. A presentation on the recommendation will be given by city staff during the July 1, 2019 City Council meeting.

- **July 3 'Stars and Stripes Celebration' at Lake Ballinger:** The fourth consecutive Mountlake Terrace 3rd of July Celebration, sponsored by the Cheeseburger Babies Foundation, is planned for Wednesday, July 3 from 3:00 to 11:00 p.m. at Ballinger Park (23000 Lakeview Drive). The celebration includes a variety of entertainment and hours of fun for all ages. The event kicks off at 3:00 p.m. with family fun and games, pony rides, water walking balls, bouncy houses, food vendors, face painting, carnival games and booths from local businesses. The stage area includes live music, a DJ, pie eating contest, gunny sack races, and introductions of local sponsors and officials. The evening's grand finale includes a fireworks show that will light up the sky with fabulous fireworks that begin at about 10:00 p.m. over Lake Ballinger. Please park at the Transit Center (6001 236th Street SW) or the former Creekside Church (7011 226th Place SW) for shuttles or walk the Lakeview Trail to the park. Only ADA parking is available onsite.

- **Town Center Plan Update Process:** The Planning Commission is conducting a **public hearing on July 10, 2019** to consider public testimony on proposed draft amendments to the Town Center Subarea Plan and related development regulations, the Economic Vitality Element and Recreation, Parks and Open Space Elements of the Comprehensive Plan. A Planning Commission meeting is also tentatively scheduled on July 16, 2019 to further discuss and consider revisions to the above referenced documents, if necessary.
- **Coffee with the City July 10:** Join city officials for a casual conversation and a cup of coffee. Residents, business owners and others from the community are invited to hear what's going on in the city, provide input about city services and events, and ask questions. This casual monthly event is scheduled at the Recreation Pavilion, 5303 228th Street SW on Wednesday, July 10, 2019 from 6:00 - 7:00 p.m. in the Jungle Room.

CITY CLERK AND COMMUNITY RELATIONS UPDATES

- **Firework Signage:** Last week the city installed signage to alert the community that the use, discharge and sale of fireworks is illegal in the city. Fifty new signs were purchased and placed around the city, including all parks. The city has done a significant amount of notification about fireworks laws and encouraging the community to respect their neighbors and attend a public display in lieu of violating fireworks laws. Some of those notifications include news releases, city newsletter article, Facebook, Twitter, Instagram, website spotlight, Notify Me subscription, Pavilion electronic sign, and website alert on the homepage.

There are two opportunities for residents to view public fireworks displays in Mountlake Terrace this summer: the July 3 fireworks event at Ballinger Park (3-11 p.m.) and at Tour de Terrace on July 27 (10:00 p.m.) at Evergreen Playfield.

COMMUNITY & ECONOMIC DEVELOPMENT UPDATES

- **Current Development Activity:** The Community and Economic Development and Engineering staff are currently processing more than 20 land use development applications. The type of development is split roughly between subdivision of property for fee-simple unit lot ownership and single family residential lots. They will add a substantial number of new single family residential housing in the city.

The applications are comprised of the following residential units:

- Townhomes in land use review totaling 78 residences
- Single-family lots subdivisions in land use review for 27 homes
- Civil construction plan review for 31 townhomes
- Civil construction plans for 56 single family lots
- Projects with pending submittal for processing totaling 107 residential units

The sum total of residential units is 299 units: 192 approved or pending construction, and 107 expected in the coming months.

Civil, building, electrical, mechanical, plumbing, and in some cases, fire permits need to be processed for each residence. This activity does not include individual home construction.

In addition, other projects staff is processing include Sound Transit's Conditional Use Permit (CUP) for light rail and reuse of Roger's Market site for interim temporary parking, the Civic Campus (City Hall) site development plan and boundary line adjustment applications, Premera Campus Renovation (5-year phased proposal), and a street vacation.

- **Civic Campus Redevelopment:** Review of a site development plan to proceed with construction of the new 18,600 square foot City Hall and 3,100 square foot expansion of the Police Station are in process. An intake meeting was held June 7. Revisions are being made to the submittal materials. A SEPA determination of non-significance has been made and will be issued June 28. A boundary line adjustment is necessary to reconfigure existing parcels on the civic campus so new construction does not cross property lines. The civic campus is located on the southwest corner of 232nd Street SW and 58th Avenue W; current development includes the library, police station and fire station.
- **Premera Campus Renovation:** The Premera Blue Cross headquarters is located between 216th and 220th Street SW and the interurban trail and 68th Avenue W (primary site address is 7001 220th Street SW). Premera Blue Cross has submitted a proposal to renovate their 39+ acre campus to replace Building 1 with a facility that provides more on-site amenities for employees and to make minor modifications to most of the four other buildings. A site

development plan application was submitted June 21 and is being revised to meet filing requirements. The proposed work includes a new Building 1 with a smaller footprint, removing nearly 200 parking spaces, creating more open space, changes in circulation, and pedestrian friendly street frontage improvements on 220th Street SW and a portion of 216th.

- **Creekside Meadows PUD:** A demolition permit has been submitted for the former Creekside Church building complex at 7011 226th Street SW. The demolition will begin mid-late July. This work precedes clearing and grading work to install soldier pile walls along the east side of the property. Significant earthwork will take place. Heavy equipment will need to use designated truck haul routes in the city and adhere to noise ordinance.
- **New Terrace Townhomes:** A 12-lot fee simple townhome development located at 4907 216th Place SW, has submitted for their civil construction permit to construct frontage and onsite improvements.

PUBLIC WORKS (ENGINEERING & OPERATIONS) UPDATES

- **Main Street Construction Update, Beginning July 8, 236th Street SW Substantial Construction:** The Main Street Revitalization Project construction work on 236th Street SW and 56th Avenue W is ongoing and on schedule. Beginning the week of July 8, significant roadway construction work will occur on 236th Street SW; this work is expected to take between 4 to 8 weeks to complete. During this period, all roadway users should expect the following:
 - **Week of July 8** – The road surface of 236th Street SW from Gateway Boulevard to 56th Avenue W will undergo asphalt grinding. 236th Street SW will be reduced to one-lane of travel with flaggers controlling the direction of traffic between westbound and eastbound travel. During this week, traffic will move from the north side to the south side, depending on which side of the roadway the contractor is working on.
 - **Weeks of July 17 through the completion of this work** – The asphalt grinding of 236th Street SW between Gateway Boulevard and 56th Street SW will be complete. Drivers should expect to travel on gravel. In addition, travel on 236th Street SW between 56th Street SW and 58th Street SW will be westbound traffic only. Drivers should use the signed detour routes or take an alternate route that may be more convenient. As construction progresses during this period, the city will provide additional construction information that is up-to-date and reflects the contractor's progress.

Drivers should expect traffic delays during these construction activities.

Weekly travel advisories on all construction projects throughout the city are provided online at www.cityofmlt.com/208 (traffic alerts). Main Street updates are shared on social media. These updates are provided to keep the community informed about the type of traffic modifications that are in place and where they are located.

RECREATION, PARKS, AND PROPERTY MANAGEMENT UPDATES

- **Summer Tennis Programs:** Summer tennis programs kick off July 2. Camps are available for children ages 7 to 13. The Jr. Tennis Team competes against teams in the surrounding area and begins practice on July 2. Tennis lessons are also available. For more information or to register, call (425) 776-9173.

Kids get to take classes in multiple disciplines including Ballet, Jazz, Lyrical, Yoga and more. Dancers will be led through a choreographic project with a performance of all their works on Friday. - **Adult Basketball League:** The summer basketball league tips off on Monday, July 15. Games are played on Mondays, Wednesdays or both days. For more information or to register call (425) 640-3105.

- **Aquatics:** Summer Swim Programs have begun. The summer swim schedule started on Saturday, June 22. The pool opened at 1:00 p.m. for the recreation swim and rentals. The late start gave Maintenance/Facility staff a chance to finish up projects that were started during the week. There was a full weekend of pool and room rentals. There will be recreation swims everyday through the summer from 12:05-1:35 p.m. Monday through Friday.
- **Swimming Lessons Have Begun:** There are daily lessons that run for two weeks, and twice per week lessons that run either Monday/Wednesday or Tuesday/Thursday. Weekends meet on Saturday or Sunday and will begin June 29 and 30.
- **New Water Fitness Class:** Aquatic Boot Camp is an all-out class that focuses on core, muscle strength, muscle toning and cardio fitness. It is strongly encouraged that participants have water shoes and a water bottle for class. This class meets Tuesdays and Thursdays from 6:00-7:00 a.m. Come check it out!

- **Marlins:** The Marlins swim team began practices on Thursday, June 27. We have a full team this year. They will practice Monday through Thursday with practice sessions in the morning and afternoons. The first swim meet will be against the Shoreline Gators at Shoreline on Saturday, July 6.
- **American Red Cross Lifeguard Instructor (LGI) Re-Entry Class:** On Friday, June 28 from 9 a.m. to 6 p.m., Mountlake Terrace is offering a Lifeguard Instructor Re-Entry class for LGI's who have let their teaching certification lapse within the last two years. They can earn it back by taking this class taught by Recreation Supervisor/Aquatics and Lifeguard Instructor Trainer, Rose Ploeg.
- **Cub Scout Service Project:** Cub Scout Den Leader Joel Fingerroot contacted park staff about having his Cub Scout Pack #76 perform a service project on July 27. Since this date is during Tour de Terrace, Joel and his pack have offered to assist in patrolling the grounds for litter and general clean up during the event. Joel and about ten volunteers of cub scouts ages 6-7 will meet with staff on site Saturday morning and help pick up litter throughout the grounds.
- **Amateur Radio Field Day:** Members of the Edmonds Woodway Amateur Radio Club participated in the annual American Radio Relay League (ARRL) National Field Day on Saturday, June 22 at Ballinger Park (23000 Lakeview Dr. Mountlake Terrace). The ARRL Field Day is an on-the-air event for amateur radio operators held annually in the US and Canada. Every June, more than 40,000 participants throughout North America set up temporary transmitting stations in public places to demonstrate public service, emergency preparedness, community outreach, and technical skills. Ten members from the Edmonds Woodway Amateur Radio Club set up a temporary transmission center at Ballinger Park from 11:00 a.m. to 5:00 p.m. on Saturday, June 22 and held a successful event. The club currently works with the City of Mountlake Terrace and other south Snohomish County jurisdictions to assist in radio communications in the event of an emergency and intend on participating in the event again next year. - **Independence Day Event:** Parks, Facilities and Public Works staff have been preparing for the upcoming Independence Day Celebration on July 3. Crews have been doing vegetation work in the area and are preparing for traffic control and assistance on the day of the event. Activities will begin at 3:00 p.m. at Ballinger Park (23000 Lakeview Dr.).

Weekly Patrol Synopsis

- On June 19 at 2:00 a.m. patrol responded to a domestic assault in the 4700 block of 212th Street SW. Upon arrival the victim stated he and his spouse are currently separated. He said they were communicating via text message and she asked him to come over. Upon arrival his wife became upset with him because her boyfriend was also on scene. The victim attempted to show the boyfriend the text conversation, upsetting his wife. She hit him on the face, grabbed his phone and broke it on the ground. The suspect was arrested for the offenses and booked at the Snohomish County Jail without further incident.
- On June 19 at 2:32 a.m. patrol responded to a domestic assault in the 5200 block of 238th Street SW. Upon arrival the victim stated he resides in the residence with his girlfriend and her mother (suspect). He stated he was making food while utilizing a head-mounted light to see what he was doing. The suspect became annoyed with the light and jumped on the back of the victim while ripping the light off his head. This action broke the light and caused visible injury to his neck. The suspect was arrested for the offense and found to be in possession of drug paraphernalia during a search incident to arrest. She was booked at the Snohomish County Jail without further incident.
- On June 19 at 10:09 a.m. patrol responded to a theft/fraud report in the 23000 block of Lakeview Drive. The victim stated she recently discovered a large sum of money electronically removed from her bank account. As part of her investigation to determine how it happened she had her computer professionally inspected. The technician discovered malware had been remotely installed enabling the transaction. Investigation continues.
- On June 19 at 6:55 p.m. patrol responded to a collision in the 4300 block of 212th Street SW. Upon arrival officers discovered a vehicle struck a tree southeast of the business parking lot. Investigation determined the driver of the vehicle to be driving recklessly upon entering the lot and due to excessive speed lost control of his vehicle. The vehicle jumped the curbing/sidewalk, traveled off the paved surface and struck a tree prior to coming to rest. Witnesses stated the driver seemed to be impaired and gave the impression he was amused by the situation. The driver was located and arrested for reckless driving. Officers were unable to develop probable cause to believe he was under the influence of intoxicants. He was subsequently booked at the Snohomish County Jail for the offense post hospital clearance.
- On June 19 at 9:59 p.m. patrol responded to a domestic assault in the 22100 block of 39th Avenue W. Upon arrival the 22-year-old victim stated he was drinking with his father when they got into an argument. His father grabbed him around the neck and threw him down. The victim said he was able to escape from his father and call 911, during which time the suspect fled from the residence. He added his father may be armed with a firearm and use it against law enforcement. Officers began a search for the suspect and found him nearby attempting to hide behind a vehicle. The suspect was uncooperative with officers demanding

they 'shoot him' as he was aggressively approaching them. Fearing an assault was imminent the officers deployed their conducted energy device (Taser) enabling them to safely take him into custody. The suspect was booked at the Snohomish County Jail for the offenses subsequent to medical clearance.

- On June 20 at 2:38 a.m. patrol observed a suspicious vehicle in the 7000 block of 220th Street SW. Investigation revealed the occupant to have a burglary warrant for his arrest. The subject was arrested for the warrant and booked at the Snohomish County Jail without incident.
- On June 20 at 4:07 a.m. an officer was returning from fueling his vehicle when a suspicious vehicle was observed in the 6000 block of 208th Street SW. Investigation revealed the vehicle to have been reported stolen. The officer reacquired the vehicle in an apartment complex. The stolen vehicle emerged directly in front of him. The officer activated his emergency equipment and the suspect began to drive recklessly in reverse in an attempt to escape apprehension. The officer performed a trained pursuit intervention technique using his push bars to make contact with the suspect vehicle and disable it. The technique was successful. The driver again attempted to flee in the vehicle, however the officer positioned his vehicle in a manner preventing the suspect vehicle from being mobile. The suspect exited the stolen vehicle and fled on foot. He was pursued on foot and apprehended hiding in nearby bushes. The suspect was found to be in possession of burglary tools and methamphetamine in addition to having a Department of Corrections escape warrant for his arrest. The suspect was booked at the Snohomish County Jail for the offenses without further incident.
- On June 20 at 5:13 a.m. patrol responded to a domestic assault in the 22300 block of 66th Avenue W. Upon arrival officers located the involved persons inside a vehicle parked at the location. They were still involved in an altercation. Officers separated the individuals. Investigation revealed them to be in a dating relationship and they started to argue while driving. The victim stated her boyfriend began to assault her and she started honking the horn to get help. She said during the fight he used a phone cord to choke her. Officers observed a horizontal cut and mark consistent with this allegation. The suspect was arrested for the offense and booked at the Snohomish County Jail without further incident.
- On June 20 at 7:13 p.m. patrol responded to a domestic assault in the 4000 block of 212th Street SW. Investigation revealed the residents to be dating and have a child in common. The victim stated his girlfriend was angry with him because he was on the phone. She threw his belongings out of the window and proceeded to try to assault him multiple times by swinging her hands at him. Instead of striking him she inadvertently struck their 14-month-old child who was uninjured. The suspect was arrested for the offense and booked at the Lynnwood Jail without further incident.
- On June 20 at 12:56 p.m. patrol responded to a death investigation in the 22600 block of 48th Avenue W. Investigation revealed the deceased, a 57-year-old Mountlake Terrace resident, was previously diagnosed with health issues. Also discovered in the residence was drug paraphernalia. It appears as though the subject died as the result of a drug overdose, however

it was not clear if it was intentional or accidental. The deputy medical examiner took custody. Investigation pending.

- On June 20 at 4:37 p.m. patrol responded a malicious mischief complaint in the 6300 block of St. Albion Way. The victim stated her ex-boyfriend was angry with her for kicking him out of her residence. He returned and began striking the door with an unknown object and forced entry. Upon doing so he yelled profanity at her then fled on foot. An area check for the suspect was negative. Case referred to the City Prosecutor for charging.
- On June 20 at 7:45 p.m. patrol located a suspicious vehicle in the 6100 block of St. Albion Way. Investigation revealed the vehicle to have been previously reported stolen to the Seattle Police Department. The owner of the vehicle was contacted via telephone and responded to the location where he was reunited with his vehicle. The vehicle was processed for evidence without success.
- On June 21 at 12:39 p.m. patrol responded to a domestic assault in the 4100 block of 224th Place SW. The victim stated she discovered drug paraphernalia in the residence and confronted her adult brother. During the subsequent argument their mother told him to leave. The suspect, who appeared to be under the influence of narcotics, violently grabbed his sister. She was able to get away and call 911. The suspect was arrested for the offense and booked at the Snohomish County Jail without further incident.
- On June 21 at 1:27 p.m. patrol responded to a sex offense report in the 6300 block of St. Albion Way. The victim reported her ex-boyfriend snuck into her bedroom while she was sleeping and took explicit photographs of her without consent. She awoke while this was occurring and kicked him out of the apartment. He later admitted via text message he did take the pictures. Officers attempted to locate the suspect without success. Investigation continues.
- On June 23 at 4:18 p.m. a resident flagged down patrol in the 4100 block of 212th Street SW to report they were just robbed at gunpoint. The victims, husband and wife, reported two masked males made entry into their residence and demanded their phones and a safe. The victim said he did not have a safe and told the suspects they had the wrong apartment. The suspects discussed the situation and the likelihood they were at the wrong apartment. They agreed to collect the victims' phones and money, then fled on foot. A K9 track was unsuccessful. The residence was processed for evidence. Investigation continues.
- On June 23 at 7:39 p.m. patrol observed a suspicious person in the 6000 block of 244th Street SW. Investigation revealed the subject to have warrants for her arrest. Patrol contacted the individual, who decided to try and get away on foot. The officer on scene gave chase and was able to grab the suspect, place her on the ground and handcuff her. Post medical clearance the suspect was booked at the Lynnwood Jail for her warrants and a new offense of obstructing a law enforcement officer.
- On June 24 at 12:20 p.m. patrol responded to a death investigation in the 6000 block of 244th Street SW. Investigation revealed motel staff entered the room and found the tenant

deceased. Signs of drug abuse were present in the room. The wife of the deceased had previously reported him missing and said they had an argument about money and his opioid addiction. Initial indication is the death was an intentional overdose. The deputy medical examiner responded and took custody. Investigation continues.

- On June 24 at 6:42 p.m. patrol responded to a probable opiate-related drug overdose in the 5200 block of 238th Street SW. Upon arrival a subject was located passed out in the street. He was administered a dose of Narcan and became somewhat coherent. Aid personnel arrived and transported the subject to the hospital for additional care.
- On June 24 at 9:01 p.m. patrol responded to a welfare check in the 22100 block of 60th Avenue W. The caller was hospitalized and unable to check on his brother who lives in the residence. Officers were unable to make contact with anyone at the residence and upon further investigation observed the resident laying on a bed through a window. Aid personnel were summoned and forced-entry was made. The resident was confirmed to be deceased. His brother told officers he was dealing with a variety of health concerns and his passing was not completely unexpected.
- On June 25 at 5:02 p.m. patrol responded to a death investigation in the 22200 block of 54th Avenue W. Investigation confirmed the resident to be suffering from health issues and his passing was sudden, but not unexpected. Nothing suspicious was discovered. Officers facilitated access to the chaplain, and arrangements with a funeral home.



On April 25, 2019, Code enforcement followed up to a parking complaint involving a wrecked burgundy Subaru located at the 5000 block of 232nd Street SW. Code Enforcement chalked the rear driver's side tire, and issued a correction notice in accordance with 10.10.190 – (Storing vehicles on the public street over 72-consecutive hours), and 10.10.230 – (Abandoned inoperable vehicles). The vehicle was removed from the area and re-parked. Code enforcement received another complaint of the vehicle located at the 23100 block of La Pierre Drive. Code enforcement issued a second correction notice, and tagged the vehicle for impound. On June 11, 2019, Code enforcement returned to the location and noted the vehicle had not moved, as indicated by the chalk marks. Towing was dispatched and the vehicle was impounded and towed.
