

CITY MANAGER'S WEEKLY UPDATE February 7, 2020

CITY COUNCIL MEETINGS

The City Council's next work/study session is on **Thursday, February 13, 2020 beginning at 7:00 p.m.** in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. The City Council agenda includes: (1) "Land Use Decision-Making" Course for City Council and Planning Commission; and (2) Review of Six-Year Financial Forecast (Tentative).

The City Council's next regular meeting is on **Tuesday, February 18, 2020 (due to Presidents' Day on Monday, February 17) beginning at 7:00 p.m.** in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. CITY CLERK AND COMMUNITY RELATIONS UPDATES

- **City Newsletter:** The February issue of *City Happenings* was mailed and delivered to distribution points around the city (Library, Senior Center, Pavilion, Police Station, Premera). Features include Ballinger Park Improvements, 2020 City Council, 66th Avenue TIB Grant, Civic Campus Redevelopment, Development Projects Update, Community Meeting on Universally Accessible Playground, new Police Department K-9 team, Salary Commission decision, Veterans Park Trail Funding, Winter Dance Gala, Spring and Summer Sports/Camp Registration and how to find information and stay informed.
- **Records Management:** The Public Records Officer conducted trainings with city departments over the last two weeks to review records disposition including transitory records and the use of disposition logs for records that are archived or legally destroyed after meeting the state's retention schedule. Departments are scheduling monthly records management days to prepare for the move to the new City Hall at the end of the year and conversion to Laserfiche, the city's Enterprise Content Management (ECM) system.
- **Event Planning:** Planning is taking place already for Tour de Terrace, National Night Out, 3rd of July and the Tree Lighting Ceremony. The Tree Lighting event will need to move from Evergreen Playfield due to the turf conversion project so city staff is considering ideas for moving the event to the Civic Campus if construction and fencing are cleared. City staff also met with the Smith family that leads the Tour de Terrace organization to prepare the agreement for City Council review in March.
- **Civic Campus History Project:** The City Clerk continued work on this project including preparing a budget for production of historical videos. Once that is completed, she will be seeking funding including sponsorships from local businesses or service organizations. The department also located letters submitted for the city's 50th Birthday Celebration in 2004 for a project called "Memories of Mountlake Terrace." Some of those letters will be incorporated into the history project for the Civic Campus Redevelopment Project.

COMMUNITY & ECONOMIC DEVELOPMENT UPDATES

- **Civic Campus Construction:** Primary construction activity this past week consisted of excavating for foundations, installation of a new stormwater line and installing foundation forms. On February 5, Allied Construction began pouring concrete for the foundation. Installation of the stormwater line continues with backfilling of the trench near the northern portion of the line. Primary access to the Police Station for the public remains from the library/police station parking lot.

- **Free Swim Lessons for Third Graders:** If you have a 3rd grader who either resides or goes to school within the boundaries of the Edmonds School District - you have this great opportunity to receive 3 sets of swim lessons for free. This free swim lesson opportunity is provided through a grant from the Verdant Health Commission. The new vouchers were distributed in December 2019. The new vouchers will expire December 31, 2020. - **Free Beginner Swimming Lesson Vouchers for Edmonds School District Students Grade K-12:** A new component of the Verdant Health Commission grant has been added to ensure that non-swimmers are given the opportunity to receive swimming lessons. Any student who is a non-swimmer can receive a voucher for beginning swimming lessons. These are only for beginning swim level 1. These vouchers are available at the participating facilities: Mountlake Terrace, Lynnwood and Edmonds/Yost (during the summer). The facilities will host a free water safety fair where swim placement evaluations will take place. Mountlake Terrace will

hold their first event for 2020 on April 11 during April Pools Day from 5-6 p.m. where there will be water safety stations.

- **Schedule Change for Staff Training:** The pool will close at 4:15 on Friday, February 7 for an All Aquatic Staff in-service. Staff will be working on instruction skills to insure consistency and to improve teaching repertoire.
- **Lap Lanes Expanding:** Edmonds School District boys swimming ends on February 14. Starting February 18, there will be 1 hour Lane Rentals available Monday through Friday from 2:30-3:30 and 3:30-4:30 p.m. Lanes 1-3 will be available to rent Residents \$37 Non Residents \$41/lane/hr. There will also be two public (shared) lanes available until 4:30 p.m. Monday through Thursday and 4:15 p.m. on Friday as well. On Monday, February 17 these lanes will be canceled and replaced with a Recreation Swim added from 2:30-4:00 p.m. for the Presidents' Day Holiday.
- **Presidents' Day February 17:** On Monday, February 17, there will be a Special Recreation Swim from 2:30-4:00 p.m. added for this day only. All aquatic programs and swimming lessons will meet as normal.
- **Water Fitness Classes:** These classes are designed to improve cardiovascular fitness, tone muscles and increase flexibility. All classes are drop-in. Class offered include Shallow Water Fitness, Deep Water Fitness, River Fitness, Water Walk, LIFT (Low Intensity Fitness Training) and Arthritis Aquatics Fitness and Aqua Zumba. Our newest water fitness class is called Aquatic Boot Camp, and meets from 6-7 a.m. on Tuesday and Thursday mornings. Come try out this challenging class with Donna. Lap swimming is available Monday through Friday from 6 a.m.-2:30 p.m., and Monday/Wednesday from 8-9:30 p.m. and Tuesday/Thursday from 8:30-9:30 p. m. On Saturdays Laps are available from 7-8:30 a.m. and Sunday from 8 a.m.-1 p.m.
- **Aquatic Staff in Training:** Recreation Supervisor/Aquatics Rose Ploeg is attending the Association of Aquatic Professionals (AOAP) conference in Frisco, Texas. She is a part of the AOAP Conference Education Committee and will be assisting with room host duties along with the silent auction that funds the scholarship program for attendees. This conference has topics that cover all facets of pool operations, training and risk management by aquatic experts from all over the United States, Canada and Australia.
- **Recreation Coordinator/Aquatics, Mark Feeney:** Mark has been accepted to participate in the American Red Cross Instructor Trainer (IT) Academy at Bainbridge Island Pool. Upon completion he will be an instructor trainer in lifeguarding and will be able to teach others to be Lifeguard Instructors. He will join Recreation Supervisor Rose Ploeg as an IT at Mountlake Terrace. The American Red Cross is the main training agency for aquatics facilities.
- **Recreation Coordinator/Aquatics Chris Barker:** On February 3 and 4, Chris attended the Washington Recreation & Park Association's Risk Management School held at the Renton Community Center. This school's core objective is to offer an educational experience to help professionals mitigate the risks inherent in the park and recreation field.

Puppygarten, a beginning class for puppies 8-16 weeks old, meets on Thursdays from 7:00-8:00 p.m. March 12-April 16. All Dog Obedience and Training classes meet in the Jungle Room at the Recreation Pavilion. The Instructor for our dog obedience classes is Caren Malgesini, CPDT (Certified Professional Dog Trainer).
- **Swing Set Installation:** Eagle Candidate Nathan Hjellen has had his project approved. Nathan will be installing a new swing set and borders at Bicentennial Park and has secured donations from the Mountlake Terrace Community Foundation. Nathan expects to complete his project in March.
- **Eagle Scout Project at Ballinger:** Eagle Candidate Steven Mudaliar completed his Eagle project at Ballinger Park. Steven hoped to start his project on December 21 but got rained out. The following weekend, he completed his project and replaced and painted the boards on all of the tables and benches at the boat launch section of the park. Steven obtained funding and acquired all of the materials necessary to complete his project and will be recognized before the City Council at the Council meeting on February 18.

CODE ENFORCEMENT PROPERTY OF THE WEEK

On January 30, 2020 Code Enforcement observed multiple nuisance code violations on a property located near the 23000 block of 55th Avenue W. Code Enforcement noted multiple piles of debris and trash, furniture, vegetation exceeding 12 inches in height, and improperly stored liquid

Code Enforcement issued a civil notice of violation in accordance with 8.15.040.A.1 – (Vegetation exceeding 12 inches in height), 8.15.040.E.2 – (Improper storing or keeping of any toxic, flammable, or caustic substances or materials), 8.15.040.H.1 – (All broken or discarded household furniture, furnishings or equipment, or any appliance not in an approved enclosed structure), and 8.15.040.I – (Accumulations of broken or neglected items, liter, salvage material, and junk not in an approved enclosed structure). Code Enforcement will continue to monitor this property and move forward with the civil process until the nuisance code violations have been corrected.
