NO COST GARBAGE SERVICE AND/OR SENIOR DISCOUNT

MAY 1, 2012 TO APRIL 30, 2013

City of Mountlake Terrace ordinances provide that qualified applicants may receive one of the following discounts:

PROPERTY OWNER AGE 62 OR OVER:
 30% discount on water/sewer/ storm water **and**
 no cost garbage service for property owners 62
 and over who reside at their property. (20 gallon can
 for 4 or fewer in household, 35 gallon can for household with 5 or more.)

TENANT OR A PROPERTY OWNER UNDER AGE 62:
 No cost garbage service for citizens of all ages
 who reside at their property or rental.
 (20 gallon can for 4 or fewer in household, 35 gallon can for household
 with 5 or more.)

To qualify for either discount applicants must prove occupancy by consumption showing on the individual water meter consistently during the discount period, and meet the income guidelines below. Discount will be cancelled if no water is used during a two month billing period and customer will need to reapply once they are using water again. Approved discounts start the 1st of the month following approval.

INCOME LIMIT FOR ENTIRE HOUSEHOLD (For each additional person over six in household add \$ 5,544)

1 person-\$ 15,638	3 people-\$ 26,726	5 people-\$ 37,814
2 people-\$ 21,182	4 people-\$ 32,270	6 people-\$ 43,358

Special Income Deductions- Medicare and supplemental insurance paid out child support or medically required attendant care.
Exceptions may be made for those whose income exceeds income limits but, due to circumstances such as illness or temporary unemployment, are in need of temporary assistance.
