

WaterSmart Toilet Program

The WaterSmart Toilet Program provides rebates of up to \$100 per toilet to homeowners who replace old water-guzzling toilets with new high-efficiency toilets that bear the EPA WaterSense label. This offer is valid for toilets purchased and installed in Snohomish County between April 1, 2010 and December 31, 2010. Program funds are limited and rebates are available on a first-come, first-serve basis. Please allow 4 to 6 weeks for your rebate check.

INSTRUCTIONS & REQUIREMENTS

1. The toilet must bear the EPA WaterSense label—no exceptions. Ask your retailer or plumber for a WaterSense toilet, or go www.ci.everett.wa.us/conservation and click on toilet rebates for a list of models.
2. The toilet must be installed in a single family home (house or condominium), or multifamily building with four or less units, located in Snohomish County, WA.
3. The rebate amount is based on the pre-tax price of the toilet or \$100, whichever is less. Rebate covers the cost of the toilet only, not additional parts, labor charges or tax. You can apply for up to two rebates, for a maximum of \$200 per home.
4. You must complete the rebate application form and return it within 90 days of the purchase of the toilet to: WaterSmart Rebate, 3200 Cedar Street, Everett, WA 98201.
5. You must attach a copy of the original sales receipt to the application. If the receipt does not indicate the brand and model number of the toilet, you must provide other documentation, such as the WaterSense label and model number from the packaging.
6. It is your responsibility to demonstrate the toilet meets the program criteria. Incomplete applications or applications lacking the required documentation will not be processed.
