CITY COUNCIL MEETINGS

The City Council's next meeting is a Work/Study Session **Thursday, March 28, 2019** beginning at 7:00 p.m. in the Interim City Hall Council Chambers, 6100 219th Street SW, Suite 220. COMMUNITY MEETINGS AND EVENTS

- **Town Center Plan Update Process:** The Planning Commission will discuss and consider the Economic Vitality and Town Center Task Force's recommended Draft Town Center Subarea Plan on **Monday, March 25, 2019** beginning at 7:00 p.m. at the Mountlake Terrace Interim City Hall, 6100 219th Street SW, Suite 220.

City staff have met twice with BERK Consulting to discuss the overall process and schedule related to preparing a Draft Town Center Plan EIS Addendum.

The city's volunteer Economic Vitality and Town Center Task Force began meeting in April 2018 and presented their recommended plan to the City Council and Planning Commission in December 2018 as part of the process to update the city's Town Center Plan. Thus far, in 2019, the Planning Commission has held four work/study sessions; the March 25 meeting will be the fifth.

Each meeting includes a public comment period, which offers an opportunity for the public to provide additional input. After a few more work/study sessions, the Planning Commission will conduct a public hearing prior to forwarding a recommendation on the Draft Town Center Subarea Plan to the City Council. - **City Hall & Police Station Addition:** ARC Architects is working with staff on options for interior finishes, including lighting elements. Based on comments being provided, ARC will be providing additional options and prepare a color board for review.

Residents, business owners and others from the community are invited to hear what's going on in the city, provide input about city services and events, and ask questions. CITY CLERK AND COMMUNITY RELATIONS UPDATES

- **Boards and Commissions:** The City Council Subcommittee recently conducted interviews for two interim vacancies on city Boards and Commissions. One vacancy was created on the Recreation & Park Advisory Commission (RPAC) when Commissioner Woodard was appointed to the City Council in February. Crystal Gamon was appointed to fill that vacancy at the March 18 City Council meeting.

The Subcommittee also interviewed two candidates on March 13 for the vacant Planning Commission position that occurred after a member recently resigned. Current RPAC Commissioner Jim Culver was appointed to the vacant position at the March 18 meeting. The Subcommittee has made a recommendation for the new vacancy on RPAC following Commissioner Culver's move to the Planning Commission. The Council will review that recommendation at their March 28 study session with formal appointment on April 1.

Additional interviews will be conducted in May for the openings that will occur when terms expire on June 30. It is anticipated that there will be openings on the Arts Advisory Commission, Planning Commission and Recreation & Park Advisory Commission.

- **Enterprise Content Management (ECM):** Staff continues with training on the new Laserfiche ECM system. Training this week focused on advanced use of automation forms and workflows to improve business processes and automate certain tasks for employees.

COMMUNITY & ECONOMIC DEVELOPMENT UPDATES

- **Former Roger's Market Building Demolished:** The City of Mountlake Terrace Community and Economic Development Department issued permits for demolition of the former Roger's Market on 56th Avenue W and the building is in the process of being demolished.

Fruhling, Inc. is demolishing the 24,880 square foot concrete masonry building, footings, and slab and 2,710 square foot mezzanine structure. The city has standards in place for erosion and sedimentation control and haul routes utilized for debris removal from the site. Traffic control is in place during removal of aging utilities in the curb line on the north side of 232nd Street SW between 56th and 57th Avenues. Demolition of the structure will provide temporary replacement parking for commuters while Sound Transit constructs the Link Light Rail Extension at the existing Transit Center and constructs temporary parking adjacent to the Park & Ride at 59th Place.

- **Conditional Use Permit (CUP):** A CUP application is in review on the light rail station and guideway impacts to the environment and properties from the proposed demolition and construction at 13 locations within the city. The 30-day public comment period on the complete application ended January 30, 2019. Review for consistency with the CUP criteria is ongoing. A public hearing before a Hearing Examiner is anticipated in the spring.
- **Sound Transit Construction Plans:** City staff continue to review the civil construction plans and provide comments and corrections to Sound Transit for the light rail construction through Mountlake Terrace. The intent is for construction plans to be ready for issuance soon after a decision on the CUP is issued. PUBLIC WORKS (ENGINEERING & OPERATIONS) UPDATES

- **Street Sweeping:** City crews started sweeping up the sand as soon as the snow left, but it is a time-consuming activity. Sweeping follows the same protocol as the original plowing with main roads getting attention first. City crews are just now getting into the residential neighborhoods, and it is expected that the work will take another 2-3 weeks to complete.
- **Lake Ballinger Back to Normal after Sewage Overflow:** King County reports that tests indicate water quality in the lake is back to normal following a sewage overflow in Edmonds at the south end of the lake. The lake reopened on Monday, March 18. The overflow is still under investigation according to King County Wastewater Division which triggered the event.
- **Main Street Construction Update:** The City's Main Street Phase 1 contractor is expected to continue sewer work on 56th Avenue W through the week of March 25 that will close the

56th Avenue W/236th Street SW intersection between 9:00 a.m. and 4:00 p.m. each weekday. Late the week of March 25, the City will provide a public update indicating whether or not this work and related intersection closure is anticipated to continue into the week of April 1. Resident and business driveways will remain accessible throughout the closure and businesses will be open. Detour routes are shown on the detour maps ([236th Street Detour Map](#) and [56th Avenue Detour Map](#)).

- **Main Street Construction:** On Thursday, February 28, 2019 the city issued a “Notice to Proceed” to Interwest Construction, Inc. (ICI) to begin Main Street Revitalization Phase 1 construction.

Phase 1 of the Main Street Revitalization Project reconstructs the deteriorating pavement along 236th Street SW from I-5 to 56th Avenue W. Once completed, the roadway will provide one travel lane in each direction, a two-way center turn lane, and bike lanes. The improvements also include wider sidewalks with trees, decorative LED pedestrian and street lighting consistent with Town Center standards, and relocating existing overhead utilities underground. The project also upgrades the 236th/56th Avenue traffic signal, installs a new signal at Gateway Boulevard, as well as underground facilities for the future traffic signal at the intersection of 236th Street and 58th Avenue.

Initial activity is anticipated to occur along the north side of 236th Street SW between I-5 and 58th Avenue. Additionally, ICI will stage construction materials at the Civic Campus site, 23204 58th Avenue W., until City Hall construction begins later this year.

Construction of Phase 1 is expected to continue throughout 2019 and into early 2020. Both directions of 236th Street will typically remain open throughout construction but full closures of the roadway (with local access coordinated with each property) will occur at various times.

Bus stops along 236th Street SW will be affected during construction and Community Transit and King County Metro Transit will provide any necessary service alerts. - **Lake Ballinger Milfoil Control:** A citizen steering committee met recently to discuss a new option for herbicide to control Eurasian water milfoil in Lake Ballinger. The new herbicide option (ProcellaCOR) has been approved by the EPA for use in potable water sources, and is scheduled to be approved by the Washington Department of Ecology April 2019. In light of this new approval, the invasive weed control strategy for Lake Ballinger is being revised, and the updated approach will be brought back before the steering committee for review and approval.
- **Hall Creek Restoration Project:** Water level and Hall Creek flow monitoring is ongoing at Ballinger Park to support the Army Corps of Engineers' feasibility study into work on creek restoration. Survey work in the park has been completed.

RECREATION, PARKS, AND PROPERTY MANAGEMENT UPDATES

- **Spring Break Special Schedule:** Aquatics will have a special schedule set for spring break with several weekday recreation swims added. The schedule is currently posted online at: www.cityofmlt.com/531 and copies are available in the lobby of the Recreation Pavilion.
- **Swim Lesson Registration:** Pre-registration for those currently enrolled will begin for the spring swimming lessons that will begin on March 25 for Monday/Wednesday classes, March 26 for Tuesday/Thursday classes and March 29, 30 and 31 for Friday, Saturday and Sunday classes. The spring session will begin the week of April 8-14.

- **RPAC and NPIS Updates:** The Recreation and Parks Advisory Commission (RPAC) and the Neighborhood Park Improvement Subcommittee (NPIS) have had some changes to their respective memberships. Erin Murray has been appointed to represent the Forest Crest Play Area after longtime representative Miriam Terry stepped down. Crystal Gamon has been selected to replace an RPAC vacancy that arose due to former Commissioner Steve Woodard's appointment to City Council. Recreation and Parks Advisory Commissioner James Culver was

appointed to the Planning Commission creating an open seat on the RPAC. City Council is reviewing applicants and intends to appoint a replacement for Commissioner Culver at the April 1 Council meeting. The NPIS has an annual tour scheduled for Saturday, March 23 to inventory and make suggestions for future improvements to all of the parks.

- **MLT BOG Begins Plantings for Spring:** The Mountlake Terrace Ballinger Organic Garden (B.O.G.) group is scheduled to work at the Mountlake Terrace Senior Center on Sunday, March 24 to plant spring flowers in beds they prepared a few weekends ago. The group is working with the Mountlake Terrace Community Foundation in hopes of starting a community garden once some of the Ballinger Park Master Plan is in place.
- **Calvary Church Volunteers:** Riley Taylor and Jessie Williams have contacted staff to arrange a volunteer effort with the Calvary Church on Saturday, March 23. The group will be working at a pocket park known as the Terrace Creek Overlook to assist in cleaning up a short trail. They also plan to remove some of the invasive plants.
- **Snohomish County Grant Application:** City staff is working with the Mountlake Terrace Community Foundation and the Mountlake Terrace Senior Center to apply for a Snohomish County “Small Capital Project Partnership” grant (SCPP). The grant would be to enhance the Mickey Corso Community Clubhouse by expanding the south deck to include a performance area and improve ADA access. The grant requires a partnership of a local entity and a community group and has a \$10,000 cap per district.

Weekly Patrol Synopsis

- On March 13 at 2:00 a.m. patrol responded to an assault in the 4300 block of 236th Street SW. Upon arrival investigation revealed the victim was assaulted by his girlfriend during an argument. The suspect was arrested and booked at the Snohomish County Jail for the crime following medical clearance.
- On March 13 at 9:20 a.m. an officer working at the Mountlake Terrace High School observed a student carrying a knife hidden under his shirt. The student was detained for school administrative staff. Charges were also referred to the juvenile court for review.
- On March 13 at 11:39 a.m. patrol responded to a sex offense report in the 5700 block of 242nd Street SW. The reporting person said she has been staying with a friend and over a period of

time has been sexually assaulted by him multiple times. The reporting person was otherwise homeless, explaining why she did not leave the residence previously. Investigation continues.

- On March 13 at 3:06 p.m. patrol responded to a disturbance in the 6000 block of 244th Street SW. The reporting person stated a subject who she suspected was under the influence was causing a disturbance and she wanted her trespassed. The subject was located, issued a trespass notification and escorted off the property without further incident.

Subsequent to further investigation the suspect was arrested for DUI and booked at the Lynnwood Jail for the crime.

The reporting person said he was arguing with his father and during the incident his father pushed him against the wall by his neck and stabbed the wall repeatedly with a screwdriver. The father was contacted by phone and denied the screwdriver allegation. He later turned himself in to police and was booked for the offense at the Lynnwood Jail.

Investigation revealed the ex-boyfriend of the victim had been following her and regularly watching her from outside her apartment in addition to threatening to harm the father of her children. The suspect was not immediately located. Investigation continues.
- On March 18 at 11:18 a.m. patrol responded to a suspicious person in the 22800 block of 56th Avenue W. Upon arrival the subject was identified and confirmed to have a warrant for his arrest. The subject was arrested and booked at the Snohomish County Jail without incident.

The reporting person, who admitted to being under the influence of methamphetamines, was difficult to get information from, but it was ultimately determined she was requesting a welfare check on her 'street mom' due to concern about her relationship with her father. Officers researched the father and learned he had an escape warrant for his arrest. Patrol contacted the residence and confirmed the suspect was inside. The suspect was non-compliant, refusing to surrender to officers. With some patience the suspect eventually exited the apartment and was arrested. He was booked at the Snohomish County Jail without further incident.

Code Enforcement Property of the Week

On November 14, 2018, Code Enforcement received an anonymous complaint of junk vehicles stored on a property located near the 23900 block of 60th Avenue W. When Code Enforcement arrived, they observed two junk/inoperable vehicles, with one of the vehicles parked on an unimproved surface. Code Enforcement issued a civil notice of violation for the following; 8.15.050.B.1-(All motor vehicles that are junk, inoperable or unused for 30 days or more shall be stored inside a fully enclosed structure), 8.15.050.B.2-(Motor vehicle's belonging to a person other than a resident may not be stored on a property outside a fully enclosed structure) and 8.15.050.B.3-(All motor vehicles shall be parked on an improved surface anywhere on a property, or on a maintained surface). Weeks later Code Enforcement returned to the location, and noted vehicles had been removed or relicensed, and parking areas were improved.



Other Items of Interest
