

## LAND USE AND DEVELOPMENT FEES

Effective January 1, 2021

### Land Use and Development Application Fees and Deposits

All application fees are minimums, based on the hourly rate in effect at the time of service. The application fee is non-refundable, with limited exceptions described below.

Trust deposits, when applicable, are in addition to the application fee and payable at time of submission. Additional deposits may be required when the trust funds have been expended. Additional deposits are based on an estimate of the number of hours anticipated will be necessary to complete processing the application and must be submitted upon request by the City.

### Fees – Nonrefundable – Exception

The minimum application fee is non-refundable, except when the Community and Economic Development Department Director approves a refund under the following circumstances:

- A written request is made to withdraw the application with a request for a refund. The request must state the reasons for withdrawing the application.
- No more than 28 days have elapsed since the application was submitted and no determination of complete application made.
- The Department Director has determined that substantive staff review of the application has not begun.
- The maximum refund is not more than 80% of the application fee.

**Note: Any administration, credit card processing, and technology fees are nonrefundable in all cases.**
